### I. NEW PH PATIENT ASSOCIATIONS

We are delighted to inform you that a PH patient group has now formally been set up in Finland. Our congratulations to Jaana Rajahalme, Tuulia Nappi and Seija Suomaki for all the hard work over the past few months in order to achieve this great result and warmest wishes for the future!

#### 2. PHA EUROPE "POSITION PAPER" ON PH

PHA Europe has convened a European PH Leaders Meeting in Vienna on 11 December 2011 to discuss the current status and future steps to take with regard to a common "Position Paper" on PH. Further to the very successful roundtable meeting held in Amsterdam on September 26 with key medical opinion leaders and patient associations from Europe, USA and Latin America a first draft is now being finalized and this will be reviewed and discussed at our meeting in Vienna. #### 3. "TIME MATTERS"

"Time matters", our new web campaign to raise awareness on PH, is well under way with about ninety posts and photos uploaded from patients and family members in Europe and around the world. The website, which was originally set up in English, is now online also in Dutch, German, Hungarian, Italian, Norwegian, Polish and Spanish. It is currently being tran-



slated into a second batch of languages (Bulgarian, Czech, French, Hebrew, Portuguese, Slovakian, Swedish and Turkish) and these new versions should be available in the next few weeks. More languages will be added at a further stage, the idea being of course to facilitate the participation of PH patients and family members from as many national assocations as possible. # 4. NEW PHA EUROPE WEBSITE

The relaunch of the PHA Europe website, with a new graphic layout and more advanced functions is currently being finalized and is due to go live in the next five to six weeks. In addition to the home page which will be in English, the website will contain sub-domains with a common text in different languages and direct links to the national association websites, to the Time matters campaign and to PH discuss (see below).

#### 5. "PH DISCUSS"

"PH Discuss" is a new website that will enable our members to download & upload important documents and files in an easy manner. Also the



platform acts as a simple Forum to have organized discussions throughout all of our countries. The Forum will be constantly updated and monitored in order to facilitate its usage.

# 6. RARE DISEASE DAY 2012

We are currently in the final stages of putting together a draft concept for the PHA Europe awareness raising campaign for Rare Disease Day 2012 (29 February). The project will be presented at our meeting in Vienna on 11 December (see above, point 2, Position Paper on PH). We

had twelve countries involved last year, we hope that even more will join next year's edition!
